liability.

2. Campaign Submission Requirements

You must submit the following information:

- Campaign Title and Description

- Featured Image and/or Video

- Reward Details (min 1, max 10)

- Campaign Duration (15 to 90 days)

- Funding Type: Flexible or All-or-Nothing

- Product Storyline and Team Storyline

- FAQs

- Your own Return, Refund, and Exchange Policy
- Contact Email for Support
- GSTIN and supporting documents as required

### 3. Review and Approval

- All campaigns are subject to a detailed review by BackingBay administrators.
- BackingBay may reject or request revisions without explanation and is under no obligation to approve any campaign.
- The Innovator has no right to claim damages or listing opportunity based on rejection or delay.

# 4. Post-Approval Rules

- Once a campaign is approved and live, the Innovator is prohibited from modifying any campaign element directly.
- Any change request must be made to shoprrway@gmail.com and shall be handled solely at the discretion of BackingBay.
- BackingBay may accept, reject, or delay such change requests without liability.

### 5. Platform Fees and Taxes

- A 9% platform commission plus applicable GST will be deducted from the total funds raised.
- An additional 0.5% TCS (Tax Collected at Source) will be deducted and deposited with the GST department. Innovators may claim this in their GST returns.
- All tax filings, obligations, and liabilities are the sole responsibility of the Innovator.

### 6. Reward Fulfillment

- Innovators are solely responsible for timely and complete delivery of all rewards, including non-material rewards.

- BackingBay provides no assurance, guarantee, or oversight over reward delivery.
- In case of any consumer complaint or legal action, the Innovator shall be directly and fully liable.
- BackingBay shall not be named a party to such complaints and will provide necessary evidence to establish separation of liability.
- Jurisdiction for any such dispute shall lie with the location of the Innovator.
